## March 2020 Behavioral Health Update

### **Advocacy and Regulatory Updates**

#### **Bill would align privacy regulations to improve care for SUD patients**

Sens. Joe Manchin, D-W.Va., and Shelley Moore Capito, R-W.Va., have reintroduced the Protecting Jessica Grubb's Legacy Act (S. 3374), AHA-supported legislation that would modernize privacy regulations affecting the disclosure of substance use disorder treatment records to better enable health care providers to coordinate care. The bipartisan bill would more closely align 42 CFR Part 2 with HIPAA regulations and strengthen protections against discrimination, while allowing patients to opt-in to share their addiction records in a variety of coordinated care settings.

The Partnership to Amend 42 CFR Part 2, a coalition of health care organizations including the AHA, applauded the bill. "The Partnership strongly believes that the modernization of privacy regulations and medical records for persons with substance use disorders, while protecting this information with enhanced penalties for unlawful disclosure and use, is a critical component for tackling the opioid crisis and will improve the overall coordination of care in the United States."

#### **House panel holds hearing on bills to address SUD**

The House Energy and Commerce Health Subcommittee recently held a hearing titled "Combatting an Epidemic: Legislation to Help Patients with Substance Use Disorders (SUD)." Subcommittee members inquired about the status of several not yet implemented provisions of the 21st Century Cures Act and SUD Prevention that Promotes Opioid Recovery and Treatment for Patients and Communities Act (referred to as the SUPPORT Act). They also discussed 14 bills to further expand access to SUD, including the following two supported by the AHA:

-The Opioid Workforce Act (H.R. 3414/S.2892) would add 1,000 Medicare-funded training positions to approved residency programs in addiction medicine, addiction psychiatry or pain management over a five-year period.

-The Mainstreaming Addiction Treatment Act (H.R. 2482/S. 2074) would eliminate a requirement that practitioners apply for a separate waiver from the Drug Enforcement Administration to prescribe buprenorphine for SUD treatment.

#### **Congress urged to consider value-based addiction recovery services payment**

The Alliance for Addiction Payment Reform, of which AHA is a convening member, recently showcased its value-based payment model for addiction and recovery support services at a briefing for congressional lawmakers and staff. AHA members are involved in the pilot program,

including Ascension Brighton Center for Recovery in Michigan. Raymond Waller, administrator of Brighton Center, is the 2020 Chair of AHA's Behavioral Health Council.

## **Increased Behavioral Health Coverage in CHIP**

Last month CMS issued [guidance](#) to states implementing Section 5022 of the SUPPORT Act, which requires all states with separate Children's Health Insurance Programs to cover specific behavioral health-related screening and preventive services for children and pregnant women. The guidance includes a template for submitting CHIP state plan amendments to comply with the section, and much more.
