# **Stabilizing** the Field's Financial Situation

#### WE'RE RAISING AWARENESS OF YOUR NEED FOR SUPPORT.

The AHA has been working throughout the year to prevent billions of dollars in proposed Medicare and Medicaid payment cuts to hospitals. These include urging Congress to reject any "so-called" site-neutral payment reductions and cuts to Medicaid disproportionate share hospitals.



AHA helped extend relief from pending Medicaid DSH cuts.



AHA and hospital leaders briefed Hill staff on why so-called siteneutral proposals would jeopardize access to care.

We continue to hit back hard against certain commercial health insurance policies that delay, disrupt and deny needed care and increase costs and physician burnout.



The AHA urged CMS in November to quickly address Medicare Advantage plan policies that do not fully adhere to requirements.

We secured an important victory - worth more than \$10.5 billion for 340B hospitals - after the Supreme Court ruled unanimously in our favor. We've pressed HHS to ensure the remedy is fairly and properly implemented.



Out of Touch with Reality: AHA Pushes Back on Editorial in The Washington Post Calling for Medicare Cuts to Hospitals and Health Systems

See AHA's statement, as well as additional details on why the proposals are divorced from reality and bad policy because they would jeopardize access to care for patients and communities

The editorial board of The Washington Post has published an opinion piece calling for payment cuts to hospitals and health systems as part of efforts to stabilize the Medicare program. The editorial calls for adopting so-called site-neutral payment policies, decreasing federal payments to teaching hospitals and reducing coverage of bad debt to 25%. It also recommends other proposals on containing costs for Medicare Advantage and raising a tax on the investment income of people who earn more than \$400,000 a year. The hospital-focused proposals have surfaced in the past and routinely are included in the Congressional Budget Office's annual option list for reducing the deficit in all government programs.

## AHA'S NATIONAL MEETINGS PROVIDED VALUABLE OPPORTUNITIES FOR MEMBERS TO CONNECT AND COLLABORATE THROUGHOUT THE YEAR.

AHA's national conferences convened members to share ideas and best practices, to celebrate achievements, hear from congressional leaders and industry experts, and connect with one another.


Rep. Adrian Smith, R-Neb., made the case for enhanced flexibilities for providers in order to improve patient care.

## Sustaining and securing our future

#### **HEALTH EQUITY**

More than 1,000 hospitals and health systems have signed up to participate in AHA's framework to support efforts to become more equitable organizations and to dismantle structural barriers to health.





#### **CYBERSECURITY**

The AHA remains committed to helping hospitals and health systems defend against cyberattacks that threaten patient care and compromise patient safety.

AHA's National Advisor for Cybersecurity and Risk John Riggi, a former FBI executive with decades of experience on the front lines of cyber issues, leads these efforts. We collaborate with federal partners on this issue, and have established an FBI advisory council made up of senior leaders from the AHA and member hospitals to address this issue.

We also have a full suite of tools and resources for members, including AHA-vetted cybersecurity services provided by outside consultants that have a proven track record of working with organizations to develop the defenses needed to protect patients and communities.





#### **PATIENT SAFETY**

The AHA has launched a national initiative to boldy reaffirm hospital and health system leadership and commitment to patient safety. Safety sprints, engagement cohorts and other opportunities begin for AHA members in 2024.

#### **BEHAVIORAL HEALTH**

We are making great strides with federal agencies on regulations, and with Congress.

We were pleased with the Senate Finance Committee's unanimous approval of the Better Mental Health Care, Lower-Cost Drugs, and Extenders Act, bipartisan legislation that includes AHA-supported provisions to improve access to behavioral health care and delay Medicaid disproportionate share hospital reductions.

#### NATIONAL RURAL HEALTH RECOGNITION

All year long we work with Congress and the Administration to enact policies to support rural hospitals, and to solidify a public policy environment that will protect access to care, advance innovation, and invest new resources in rural communities.

Every November the AHA shines a light on the rural hospitals and health systems working tirelessly to provide local access to care for the 61 million Americans who live in rural areas.

#### WORKFORCE

#### We are tackling the workforce challenge on multiple fronts, including:

- Helping to enact legislation that will provide an additional 200 Medicare-funded graduate medical education residency positions beginning in 2026.
- Producing comprehensive resources to address members' workforce challenges, including a recent addition to the Strengthening the Workforce series, a set of strategies regarding hiring veterans, professional governance models and academic-practice partnerships.
- Continuing to advocate for legislation to give health care workers the same legal protections against assault and intimidation that flight crews and airport workers have under federal law.
- Developing leaders and empowering them to bring about real and lasting change through our Next Generation Leaders Fellowship, which pairs rising hospital leaders with mentors to work on an issue at their organization.
