# ANGELA L. SCIOSCIA, M.D., TO LEAD AHA'S SECTION FOR MATERNAL AND CHILD HEALTH GOVERNING COUNCIL

WASHINGTON — Angela L. Scioscia, M.D., chief medical officer (CMO) at the University of California (UC) San Diego Health System, is the 2014 chair of the American Hospital Association's (AHA) Section for Maternal and Child Health Governing Council. The governing council is a 14-member body comprised of CEOs and senior executives from the nation's women's and children's health care providers. As chair, Dr. Scioscia will lead the section's governing council on public policy issues concerning women's and children's health, hospitals serving that patient population and AHA member service strategies.

Dr. Scioscia has more than 25 years of health care management and leadership experience, serving as CMO of UC San Diego Health System since 2004. As CMO, she works to ensure that the highest safety and quality standards are being met, and that the UC San Diego Health System staff works together to provide patient-centered care through a multidisciplinary and integrated approach.

Dr. Scioscia, a professor in reproductive medicine, is board-certified in obstetrics and gynecology, maternal-fetal medicine and medical genetics. She is actively involved in the training of medical students and residents. Prior to her role as CMO, she was the director of the UC San Diego Fetal Diagnosis and Treatment Center for 15 years.
